

WOOD COUNTY EMERGENCY COMMUNICATIONS INC

September 3, 1996

Meeting called to order at 7:05 PM by Ken Harris, WA8LLM/Unit 251 President, and Duane Jones N8LDM/Unit 260, RACES Radio Officer. There were 7 members present.

Minutes from the August 6th meeting were read and approved.

The Treasure's report was read and approved.

OLD BUSINESS

Sam, N8SVX gave a report about the Grant Writing classes that he has attended. He said that he attended that last meeting, which was a boat ride on the Ohio River. While at the meeting he was presented a check for \$2000 dollars. The grant money will go toward the purchasing of a Low Band Radio, antennas, and a programming cable. The cost of the equipment will be around \$2030 dollars. He said if we could come with a Logo for the grant money, we could also win an additional \$100 dollars.
