

WOOD COUNTY EMERGENCY COMMUNICATIONS INC

September 8, 2005

The monthly WCEC meeting was called to order at about 7:00 pm by Ken Harris, WA8LLM/Unit 251 President. There were 29 members and guests present.

Minutes from the August 2, 2005, meeting were read and approved.

The Treasurer's report was read and approved.

OLD BUSINESS

Ken, WA8LLM, gave a report on the 147.255 repeater system. Ken said the new UHF radios that will be used as Link Receivers at the repeater transmitter have been ordered and are in. Now he needs to get some time to get to the repeater and get all eight UHF Link Receivers working again. The Ritchie County Remote Receiver has been changed out and it seems to be working good. We needed to get the Ritchie County Receiver fixed so that we could use it for the MS-150 coming up on September 10th and 11th. The repeater seems to be doing good, but we still have a few dead spots. But, until we get all the Remote Receivers the same, and the voter audio lined up, there will be a few problems.

Ken, WA8LLM, said that while he was at the West Virginia Interstate Fair and Exposition, he talked to Tom Graham about getting a trailer built the way we want it. Tom said that with the companies he is working with he's not able to get a trailer built the way we want it. We are still thinking and talking about how we want it built. Ken said that he stopped over to Tractor Supply Company, and they sell tandem axle trailers, but they are wanting \$3500, we can buy the same thing in Ripley for \$800 or \$900.

There was another reminder about the Medical Information that will be put in the back of the new ID Cards. They need to be turned in as soon as possible so they can be typed up and ready to put with the ID Card. No ID Cards will be made up without the Medical Information inclosed on the back.

There has still been no date set for an Amateur Radio Class for the Civil Air Patrol, or the Health Department employees.

Ken, WA8LLM, said that he didn't get the Grant Application filled out and sent in for the Alinco DR-135s and DR-435s by the September 1st deadline. He still needs to put together a budget form. Denise, KC8TUF, E-Mailed Ken a sample budget form. Now he can start putting one together. The next deadline for the grant is March 1st. Terry, KC8TUE, said that he has a little time on his hands, that maybe he would be able to help put the grant together.

The rain jackets were brought to the meeting. They weren't what we were expecting, but that's what we got. Everyone went through the box, and took what ever they wanted.

Ken, WA8LLM, gave a report on the Parkersburg Homecoming BINGO, and May Flies. The 15% check has already been sent to the Homecoming Committee.

There was a reminder the Volcano Days BINGO will be held on September 23rd, 24th, and 25th at Mountwood Park.

Ken, WA8LLM, said that he has talked to Roger Bibbee about taking the NIMS training course. Roger said that all Tuesdays in September are tied up, but every Tuesday in October is available. The group decided to check on October 25th for the training. Ken will check with Roger on the training date.

Ken, WA8LLM, said that he and Dot, KC8HAI, went to the BINGO Seminar in Clarksburg the Monday after the Parkersburg Homecoming. There is no new BINGO laws that were created this year. A short discussion followed.

There were several incidents of runners having problems and needed help. A short discussion followed. Carol, KC8TUD, suggested the Water Stops be identified by letter rather than numbers to keep the confusion down between the Mile Markers and the Water Stops. Ken said that he would talk to the officials about it.

There was a short discussion about the Homecoming Parade. Who ever was in charge of the parade changed all of the numbers of the parade entrees. We were unable to send the information from the Starting Line to the Finish Line.

### NEW BUSINESS

Ken, WA8LLM, said that he needs to contact the Ritchie County Amateurs and get their assignments and T-Shirt sizes, and call them to the MS-150 coordinator, when he gets home.

Dave, KC8VLK, said there will be a Fun Run, sponsored by the Lubeck Volunteer Fire Department. The foot race will be held on October 1st. Those helping with the race will have a pancake breakfast after the race.
