



## **WOOD COUNTY EMERGENCY COMMUNICATIONS Inc.**

### **Minutes of May 3, 2016**

**The May 3rd business meeting was called to order at 7:00 pm by Ken Harris, WA8LLM/Unit 251, President. There were 16 members and guests present.**

**A motion to accept the April 5, 2016 minutes, as they were E-Mailed, and after they were corrected, was made by Matt, KD8WHN, and seconded by Joe, KD8YVB. Motion carried. Printed copies of the minutes and agenda were also available at the meeting. The Treasurer's Report was read. A motion to accept the treasurer's report was made by Bill, N8JXO, and seconded by WV8DOC. Motion carried.**

### **OLD BUSINESS**

**Ken, WA8LLM, said that he and Dot, KC8HAI, and Sammy, N8SVX, stopped by the Wirt County Remote Receiver site on the way home from the Jackson County Hamfest on Sunday, May 1st. They had to rotate the beam antenna back toward the Mountwood Park transmitter site to get the remote receiver back in operation. Ken said that he is going to build another antenna outrigger so the antenna will be more stable. A short discussion followed.**

**Terry, KC8TUE, couldn't make the meeting so there was no donation letter report. The group didn't know the mailing address that was on the donation letters. While the discussion was going on, Judy, N8UFQ, sent a text message to Terry to find out what address was used on the Donation Letters. Terry said the address was 319 Communications Drive. If the address is 319 Communications Drive, then there has been no donations returned.**

**Ken, WA8LLM, said the 443.175 MHz Repeater is working just fine. The repeater worked great when it was used for the Challenge at Mountwood Mountain Bike Race on April 10th.**

**The Jackson County 444.150 MHz repeater is still on hold until the Kenwood 443.175 MHz repeater has been changed out with the Motorola repeater.**



**Ken, WA8LLM, said that Walt Smittle, the Jackson County Emergency Services Director asked him how things were going with the equipment that was donated by Jackson County, and to be used on the Amateur bands. Ken is still trying to find out if it is legal to operate a digital transmitter on the 900 MHz Amateur bands. Ken has E-Mailed a message to a friend of his who used to be the President of a Microwave Radio group in California, but hasn't heard anything back.**

**Ken, WA8LLM, said he is not for sure if the Motorola Maratrac 100 watt mobile radios will be capable of being keyed up for a long period of time for use on the CW Practice transmitter, but he will still be working on it.**

**Ken, WA8LLM, said he brought some ARES Forms to the meeting. Anyone that hasn't filled out one, or needs to change equipment should fill it out, and give it to Terry, KC8TUE, or himself. **Ken, WA8LLM, reminded everyone to keep track of their volunteer hours and turn them into one of the WCEC officers.**

**Cathy, KC8DJJ, reminded everyone about the one day Technician Class license class that will be held on May 14th. Ken, WA8LLM, said that he has had a couple of people that would like to take the class. Ken gave them all the information about the class.**

**Cathy, KC8DJJ, reminded everyone the October Fest event will be held at the Lubeck Civic Center on October 22nd from 11:00am to 4:00pm. So far there are about 30 people wanting to set up tables.**
